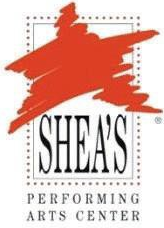

ONLINE SAFETY POLICY

Shea's Performing Arts Center ("Shea's PAC") is committed to providing you/your child with a safe online learning experience. As a participant in the Shea's 2021 Kenny Awards Program you have the opportunity to take part in workshops, masterclasses, and instructional coaching. You/Your child may be using the Zoom meeting platform to access instruction. Zoom links will be changed daily and sent to the parent's/guardian's email address (as well as to any participant email addresses) provided to Shea's PAC. For participants who are 18 and older, Zoom links will be sent to the primary email address provided on the application. Shea's PAC will record and archive all virtual classes.

By applying for the 2021 Kenny Awards Program, you are giving permission for you/your child to access the Internet to participate in online learning. This requires the use of:

Webcams. Participants will need to use webcams for group and individual activities. Participants will not be asked to remain visible on the webcam outside program hours.

WeTransfer, Google Classroom, Shea's PAC web page. Class materials will be made available through the online Google Classrooms platform or via a private Shea's webpage. Instructors may request that your student upload their work to one of these or a similar platform for review or to collaborate in final group pieces.

Email. Zoom links and other confidential communication will be sent through email to the parent or guardian account responsible for registering the participant. Email communication and links will not be forwarded, posted, or otherwise published without written permission.

Social Media. Participants will access social media platforms such as YouTube to watch videos relevant to their learning, including videos created and edited by Shea's PAC that include the participants' image and voice.

Additionally, you are agreeing that:

(If participant is under 18) A responsible adult will be present or within calling distance while your child is participating in 2021 Kenny Award activities.

You/your child will not share the work of others that is created at the 2021 Kenny Awards programming on any other platform without the written permission of the creator. (For instance, do not share someone else's videos/comments without their permission). Participants may not personally record sessions.

You/your child will not engage in any hate speech, discrimination, or cyberbullying of any kind. Such behavior may result in expulsion from the program with no refund provided.

Shea's PAC assumes no liability for injury or damages arising from the result of participation in its online classes, workshops, or programs.
